I am directed to inform you that the assessments to assess the standard of examination held by Pt. B. D. Sharma University of Health Sciences, Rohtak and to assess the physical and the other teaching facilities available for Recognition/Approval of ESIC Medical College, Faridabad, Haryana for the award of MBBS degree (100 seats) granted by Pt. B. D. Sharma University of Health Sciences, Rohtak u/s 11(2) of the IMC Act, 1956 were carried out by the Council assessors on 1st December, 2019 and 4th & 5th February, 2020. The assessment reports (1st December, 2019 and 4th & 5th February, 2020) along with the summary/observations of the member of the Undergraduate Expert Group appointed by the Board of Governors were considered by the Board of Governors and it was decided to recommend to the Central Government for recognition/approval of ESIC Medical College, Faridabad, Haryana for the award of MBBS degree (100 seats) granted by Pt. B. D. Sharma University of Health Sciences, Rohtak u/s 11(2) of the IMC Act, 1956.

The Board of Governors further decided that the attention of the institute be drawn to Sections 8(3)(2), 8(3)(3) & 8(3)(4) of the Establishment of Medical Colleges Regulations (Amendment), 2010 (Part II) dated 16th April 2010 and act accordingly at appropriate time, which reads as under:-

8 (3) ...

(2) The recognition so granted to an Undergraduate Course for award of MBBS degree shall be for a maximum period of 5 years, upon which it shall have to be renewed.

(3) The procedure for 'Renewal' of recognition shall be same as applicable for the award of recognition.
